**HOW TO LEAVE A GIFT IN YOUR WILL TO THE OPERA AUSTRALIA CAPITAL FUND**

Refer to this checklist to ensure that your intentions are clear and carried out according to your wishes.

**1. Consult your family and friends**

We encourage you to talk to the important people in your life about your legacy intentions for the Opera Australia Capital Fund.

**2. Decide on your gift**

There are several ways of remembering Opera Australia in your will after your loved ones have been provided for. These include, but are not limited to:

**A percentage of your estate**

This means that the value of your bequest to the Opera Australia Capital Fund will adjust over time according to any fluctuation in the value of your assets.

**A fixed gift**

This may be a specified monetary sum or another type of asset such as shares, art or real estate.

**The residue of your estate**

This is a gift of all or part of the value of your estate, once all your other commitments have been settled.

We especially encourage donors to make their gift to the Opera Australia Capital Fund **unrestricted** (see “Suggested wording” below), rather than specifying a particular purpose or activity. Such unrestricted gifts mean your generosity will support Opera Australia’s greatest needs as they change over time. If you are thinking about requiring that your gift should be applied for a specific purpose or activity of Opera Australia, we very much hope you will get in touch to discuss your ideas with us before making or changing your will.

**3. Speak to a professional**

Information provided on this website is for general guidance only. It is important that you seek expert tax and estate planning advice about your particular circumstances when writing or updating your will.

**4. Include this basic information**

## 5. Suggested wording

The following sample wording may be useful for general guidance. You may wish to take it to your solicitor when the time is right.

*I give to Opera Australia Capital Fund Limited as trustee of the Opera Australia Capital Fund:*

*The sum of \$\_\_\_\_\_*

**or**

*\_\_\_\_\_ % (a specific percentage) of my estate;*

**or**

*\_\_\_\_\_ % (a specific percentage) of the residue of my estate;*

**or**

*\_\_\_\_\_ (describe precisely the specific asset you wish to leave) free of all charges,*

*as a contribution to that Fund to be applied for its general purposes and I declare that the receipt of the Opera Australia Capital's Fund General Manager or other proper officer for the time being of the said trustee shall be a complete discharge to my executors/trustees therefore.*

## 6. Amend an existing will

If you already have a will and the main provisions, including your marital status, are still current, you can amend it to include a gift to the Opera Australia Capital Fund by adding a separate document called a codicil. Speak to your solicitor for further advice on codicils.

## 7. Get in touch

Wills are a very personal matter and we understand if you would prefer not to inform us of your intended gift to the Opera Australia Capital Fund. However if you do let us know, you can be assured that any information you share with us will be treated in the strictest confidence. You will also be invited to an annual special event.

If you intend including the Opera Australia Capital Fund in your will, let us know by:

- returning a **Response Form**
- sending us a copy of the relevant section of your will, or
- sending us a letter of confirmation from your solicitor, or
